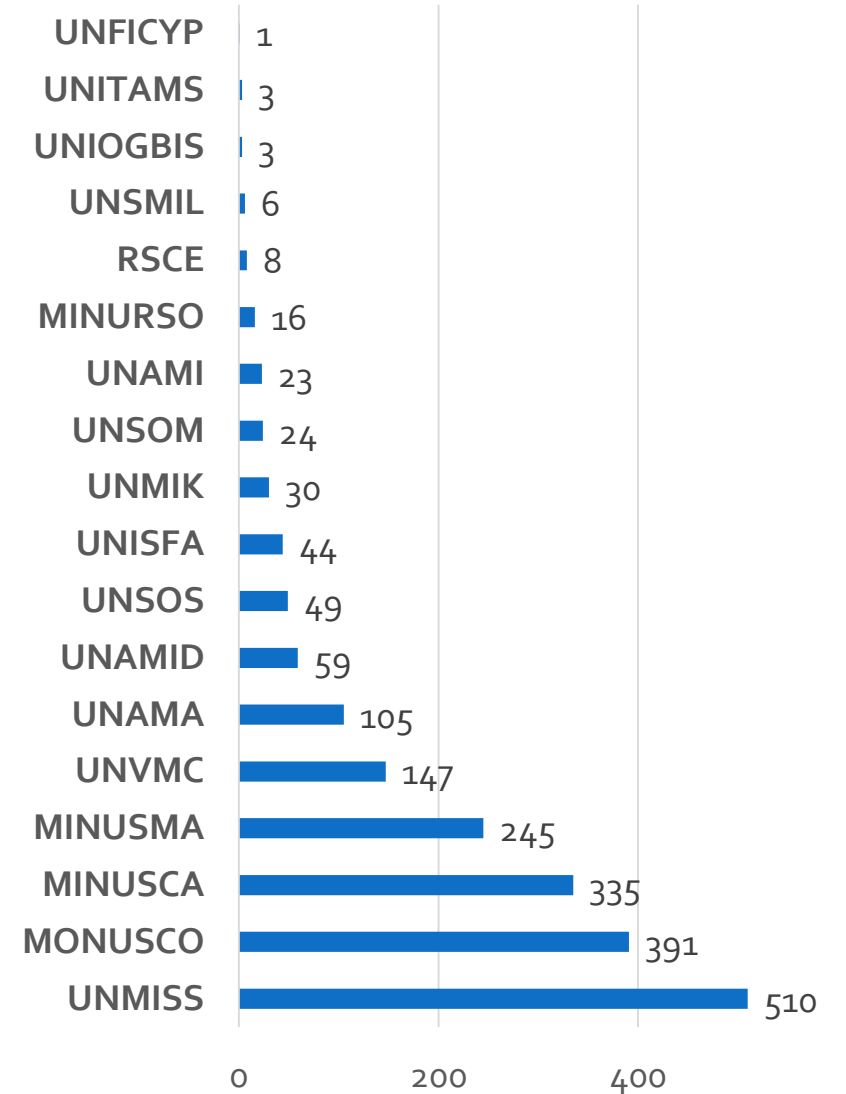

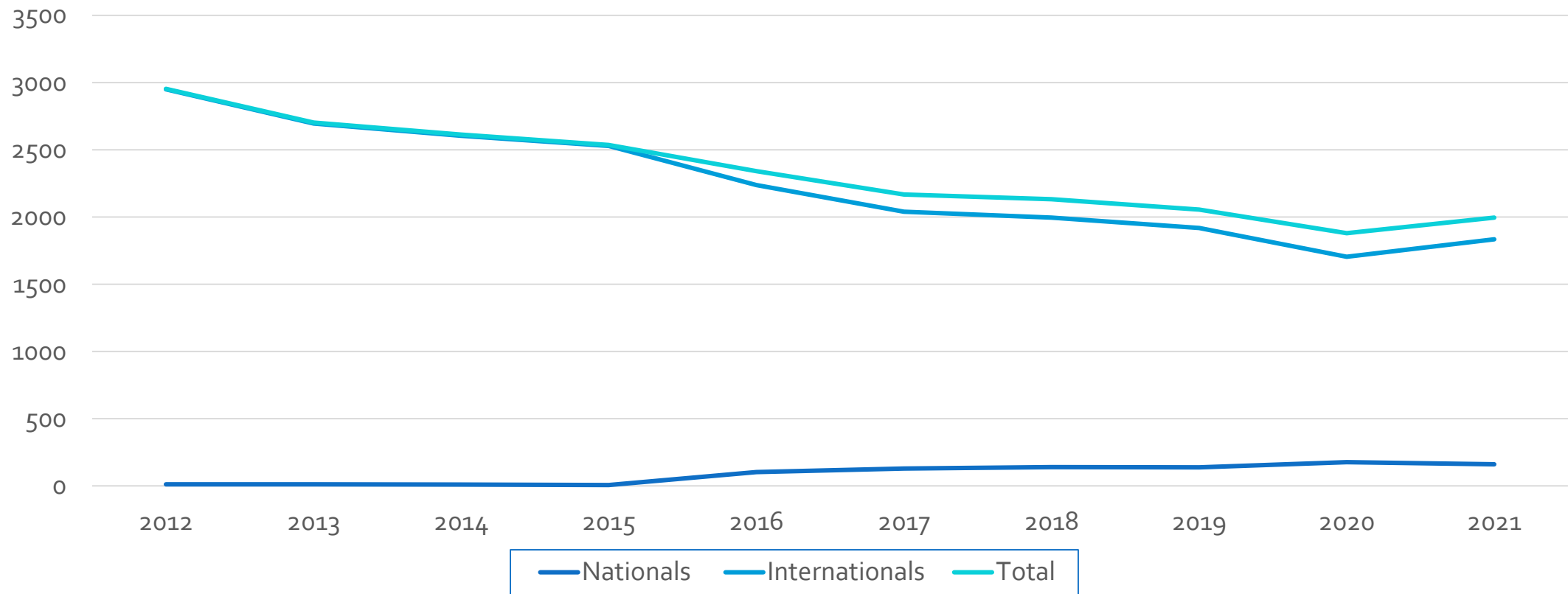

In August 2016, the Central African Government and the UN system signed off on a five-year joint project to support the creation of a Special Criminal Court, the overall objective of which is to contribute to fighting against impunity, mending the rule of law and social cohesion and supporting the process of national reconciliation. UNV's support to the Special Criminal Court represents a component of this joint project focused on outreach activities that ensure the involvement of Central African Republic's population, especially those particularly affected by the crimes falling under the Court's jurisdiction. UNV leads activities that target the local communities, including youth and women, and aim to sensitize on the role, mandate and functioning of the Court.

UN Volunteers advance peace process through verification of cease fire, demobilisation and disarmament in Colombia

In 2016, the United Nations Security Council unanimously adopted Resolution 2261 to establish the UN Mission in Colombia (UNMC), a political mission of unarmed international observers deployed across the country. Sixty UN Volunteers were mobilized to support the tasks of verifying compliance with the peace agreement between the Government of Colombia and the Revolutionary Armed Forces of Colombia–People's Army (FARC-EP), accompanying and monitoring the peace process and promoting a culture of peace.

In the Western and Central African region alone, more than 750 UN Volunteers support the mandates of three major peacekeeping operations in Mali, DRC, and the Central African Republic, out of seven on the African continent. They work as part of the civilian component of missions, in the fields of protection, conflict prevention, rule of law and national capacity development. Almost 37 per cent of these volunteers are women delivering contributions that are key to peace.
